2nd workshop, "Creating impact with open data for agriculture and nutrition"

Dear Sir/Madam,

Open data offers great opportunities for informed and transparent decision making, as well as for developing a data-driven economy. The 1st workshop on "Creating Impact with Open Data for Agriculture and Nutrition" culminated in the conclusion that additional action was needed in order to outline clearly how tools, data sets, networks and initiatives can be routed towards having an impact and how to use this insight to develop more general views on the role of open data in achieving impact. Organised in collaboration with Wageningen University and the GODAN Secretariat, this workshop will be hosted by – and held on-site at – the Netherlands Ministry of Economic Affairs.

The objectives of the 2nd workshop are:

- To develop a shared general understanding of what it takes to generate societal impact with open data in the field of agriculture and nutrition;
- To develop a concrete and specific approach for achieving that in the following areas:
 - a. The realisation of Sustainable Development Goals (SDGs) targeted at the economic, environmental and social dimensions of sustainable development;
 - Innovation that contributes to the transition processes and citizen participation required for achieving point a) above, e.g. with regard to economic processes/business activity and improved governance;
 - c. Improved strategic decision making.
 - To explore routes towards creating an impact, business models for open data, and good practices.

The workshop will bring together a variety of key players from public, as well as private sector organisations at the national, international and global levels: governments, businesses, consultants, universities, research organisations and NGOs. Participants are invited to share their views, practices, success stories/failures and business cases, and to outline - in an open process of interaction and discussion - concrete steps for actively turning the power of open data into actual impact.

The focal question in this 2nd workshop will not be "what should the desired impact look like," but rather, "how to achieve this impact." This requires a specific format and a more hands-on and action-oriented approach. To make this possible, the scope for the workshop has been narrowed down somewhat to "food & nutrition security."

 - A private sector perspective (lead: Ministry of Economic Affairs)

Brief reflection on day 1 and what it means for day 2

Plenary Introductions on:

- Developing business innovations with open data (GODAN)

Parallel discussion in groups focusing on the following questions (each group to discuss all 3 questions):

- Potential for future developments.
